A grant from the LTC can be completely life changing for individuals and their families who are struggling to get back on track.








Our approach is holistic, we provide tailored support





The LTC provides life changing scholarships and bursaries

105 children of parents in the licensed trade were supported with grants for school trips, laptops, school uniform and a 20% discount towards places at LVS Ascot. 15 pupils were partially or fully funded by the Charity to attend the school.



LVS Ascot

Our mainstream day and boarding school in Ascot, situated in 26 acres of beautiful parkland, offers outstanding purpose-built facilities, impressive academic results and small class sizes for boys and girls aged 4-18.

While the school accepts students whose parents work in all professions, we maintain preference for those from licensed hospitality, offering discounts, scholarships and bursaries.

The school has undergone a complete transformation in the way its curriculum is delivered.

The 4Cs 21st Century Skills (collaboration, critical thinking, communication and creativity) and the use of digital technology are completely embedded in our teaching, raising outcomes and improving the learning experience for all of our students.

LVS Hassocks and LVS Oxford offer a specialist education for children aged 11-18 with a diagnosis of autism, encouraging students to learn without limits.




The schools offer academic and vocational pathways that support students to reach their potential...

How we work




2022 has presented some challenges...



We are committed to a more sustainable future and have continued to promote sustainability and environmental awareness across the organisation, with a focus on improving energy performance and reducing our carbon footprint.




75% of old candescent and fluorescent fittings replaced with LED energy efficient lighting.




We know that our range of support services meets the needs of the sector...
